HEALTH RELATED BEHAVIOUR SURVEY 2022

Our school, along with many others across the City, has agreed to participate in a very important Health Behaviour Survey amongst children and young people. We have been asked to take part in order to support the work of the Local Authority and Public Health Team and we also stand to benefit through our participation in the survey by obtaining opinions from our pupils, so we can improve our provision for them.

Previously, the survey data in schools has also been used in a variety of ways including:

- 1. As a starting point for discussion in classroom activities or lessons.
- 2. To improve work on the health and well-being of pupils.
- 3. To support the development of professionals and schools.
- 4. As a beginning for further enquiry to strengthen existing programmes or curriculum, e.g. PE, Healthy Eating etc.
- 5. To help schools track their progress.

The survey method that we are using has been developed by the Schools Health Education Unit, Exeter and has been in use now for over 40 years. Over 3000 schools across the country have taken part, many of them regularly repeating the survey.

The age appropriate questions concern a wide range of health behaviours, for example:

Home and family Relationships, emotional health and well-being,

Tobacco, Alcohol, Leisure and money

Healthy Eating Exercise

Drugs

The Local Authority and Public Health Team will also have a reliable database upon which it can objectively plan provision for children and young people.

Both the Local Authority and the school find the content of the questionnaire acceptable; it has been customised to suit our local setting in Wolverhampton for Primary Schools.

Each questionnaire is anonymous and confidential, and no pupil will be identified when the data is returned to our school. The Local Authority and Public Health Team will not use data to identify individual pupils or individual schools in its wider reporting.

I hope you will agree with us that this is an exercise in which we wish to co-operate fully and will be of real benefit in helping to shape provision for our pupils.

If you have any queries regarding the survey, then please contact the school office.

As part of the survey, it will be helpful if your child brings the following information: -

♦ their postcode

(this will be used only for drawing maps of results in the area; your house will not be identified in any way)

The survey will be carried out this week in school. Parents do not need to take any action. The 2nd page of this letter is the first page of the survey which explains to the children the purpose of the survey. Thank you for your support.

Privacy Notice – school surveys



1. Who are you?

We are a research unit in South-West England. We have been asked by the school or the Council to help collect information from young people. www.sheu.org.uk

2. What will I be asked?

You will be asked about your habits and feelings, and other important things about you.

You will not be asked for your name or address, and please don't tell us!







3. Why do you want to know this?

The reports are used to plan lessons and services for young people, and to see what has changed since the last survey.

The school will see if your lessons fit in with what you and other young people tell us. We want to be sure what we are doing is right.

4. How will you use my information?

We will send reports to schools and the Council, showing them how many pupils gave different answers. The reports might say things like:







5. How will you collect this information?

We are going to ask you questions in a questionnaire, on a website or in a printed booklet.



6. How do you keep this information?

Your answers will be kept safe on our computers. We keep records for many years, so that we can see how young people's lives are changing.



7. Are you allowed to do this? ('legal basis for processing')



The Council is allowed to collect information to help it plan and monitor things it does to support young people's education, health and wellbeing – the sorts of things it has to do ('legal functions' and 'public interest').

SHEU is allowed to use information to produce its reports as long as no-one can tell what answers you gave ('legitimate interests').

8. Who gets to see the information?

Only staff from SHEU and from the Council who need to see the information to do their job are allowed to see your answers. They won't show your answers to anyone else. Everyone else sees only percentages. No-one in your school sees your answers.



BUT if you tell us something that makes us think you are in danger, we will have to tell your school that someone has said it, even if we can't find out who you are.

9. What's next?



If you agree with all this, please tick the box at the start of the survey. If not, don't take part.

You can leave out any questions you don't want to answer, and you can stop at any time.

Later, if you want to see what we know about you, you can ask, and you can tell us to delete it. But remember, we might not be able to find your answers.
